

## **Return-to-Office Landlord Building Status**

As we begin our return to the office, your safety is our top priority. In offices that we occupy along with other businesses, you may notice different common space protocols put in place by the building's landlord. To ensure we're prepared to face whatever changes have been made to our workplaces for our collective safety, we've summarized notable differences you can expect to see in these multi-tenant buildings by location. Regardless of the landlord's common space protocols, it is still best practice to mask when unable to maintain a 6' physical distance and practice appropriate hand hygiene, washing with soap and water for 20 seconds.
